Rajeev Vasudeva is currently an independent director at Brookfield Infrastructure Partners, one of the world's largest owners and operators of critical infrastructure networks, listed on the New York Stock Exchange and Toronto Stock Exchange. In addition, he is also a director on the board of Marico Industries (a family-owned Indian multinational consumer goods company), and Pidilite Industries (a family-owned Indian adhesives manufacturing company).

Mr. Vasudeva was previously a partner in Egon Zehnder - the global senior leadership talent advisory and search firm - for 25 years. He had founded and led Egon Zehnder's practice in India and been on the global executive committee prior to becoming the global CEO between 2014 and 2020. He advanced Egon Zehnder's global leadership position by growing its geographic footprint and extending its range of service offerings from executive search to leadership advisory and digital transformation. Under his leadership, the firm delivered record revenues.

Mr. Vasudeva holds a Bachelor of Arts in Economics from the University of Delhi, a Bachelor of Laws from the University of Delhi and an MBA from the University of Michigan. He is a chartered accountant.

Leslie Teo is currently a senior director at Al Singapore, the Singapore government's coordinating body for promoting Al across society, where he is tasked with catalysing the use of Al in businesses by helping to identify important use cases and building products to support them.

Dr. Teo also serves as an independent director at Coinbase Singapore and Lion Global Investors, and is also an Industry Advisor to Sygnum, a digital bank.

Dr. Teo's earlier career was as an economist at the International Monetary Fund (IMF) and at the Monetary Authority of Singapore in the years between 1996 and 2008, culminating as deputy division chief at the IMF. In 2008, he joined the GIC, the sovereign wealth fund of Singapore, where he rose to become director of economics & investment strategy, and chief economist between 2011 and 2019.

Fascinated by data science, machine learning and AI, Dr. Teo pivoted in 2019 to become the head of data science, policy and data initiatives at Grab, a consumer superapp focused on SE Asia. He then moved to Great Eastern Life Insurance to help the company in data and strategic transformation.

Mr. Teo holds a Bachelor in Liberal Arts & Economics from the University of Chicago, a PhD in Economics and Finance from the University of Rochester and a Master of Information and Data Science from the University of California. He also attended the Advanced Management Program at The Wharton School Philadelphia in 2010.
